

- Common updates include, but are not limited to: Annual Meeting registration info, calendar of events, board and committee members, etc.
- Encourage and support participation in the Association's list server. Currently, messages can be distributed to the group through the list server via email. The list server's name is MissouriMappersAssoc-L and it is maintained at the University of Missouri.



## Mapping the Cadastre - Darrel D. Pratte PLS

In 2009, the Missouri Society of Professional Land Surveyors took up the cause of creating a standard for the cadastral layer associated with Geographic Information System (GIS) mapping. This first effort failed due to miscommunication between the surveyors, the GIS mapping community, and county assessors – the primary user of cadastral mapping data. The 2010 effort to create a cadastral mapping standard has met with success and stakeholders are currently working to create a draft standard.

The Missouri Department of Natural Resources' Division of Geology and Land Survey's Land Survey Program is responsible for involving stakeholders and proposing a standard. One part of the program's mission is to preserve and protect the corners of the Public Land Survey System (PLSS). This includes the physical monument that marks the corner and the record documents that establish and perpetuate the historic location of the corner. The Land Survey Program is instrumental in interpreting the location of the PLSS layer for the Missouri GIS maintained by the department. This is the same data the department makes available through the Missouri Spatial Data Information Service, also known as MSDIS: [msdis.missouri.edu/](http://msdis.missouri.edu/)

The object of the legislation, hence the object of the standard, is to develop a rule that benefits any mapper, any GIS professional, and any map user having a need for accurate cadastral data. The map layer governed by this rule is the layer on which the PLSS and record subdivisions of the PLSS reside. The original surveys performed by the General Land Office (GLO) in the first half of the 19th Century are the genesis of all real property in the state. Their importance to the creation of an accurate cadastral layer cannot be overstated. Fine-tuning the PLSS corner positions is dependent on record surveys subsequent to the GLO. Measurements from 19<sup>th</sup> Century County Surveyor records, mid-twentieth Century suburban subdivisions, and early 21st Century gathering of Global Positioning Satellite (GPS) data will help the mapper produce a reliable cadastral layer. Proper use of record survey data is vital to an accurate cadastral layer. In order to be part of the cadastral layer it must be of record, and if it is of record it must be part of the cadastral layer.

The first of several stakeholder meetings was held September 8, 2011. Three workgroups were formed consisting of assessors, GIS professionals, and surveyors. The goal of each workgroup is to create a single rule that addresses their specific area of expertise. The workgroups will meet and propose a draft rule. At the next stakeholder meeting, which is scheduled for November 10, 2011, the newest iteration of the draft rule will be presented to the three workgroups. The final stakeholder meeting will be held December 8, 2011. Once the workgroup agrees on a proposed rule, it will be submitted to the Secretary of State for publication in the Missouri Register for public comment: [www.sos.mo.gov/adrules/moreg/moreg.asp](http://www.sos.mo.gov/adrules/moreg/moreg.asp)

Missouri will one day have a cadastral layer that is contiguous from county to county and State Plane Coordinates on PLSS Corners will be an everyday occurrence. Surveys that create new parcels or subdivisions will easily integrate into maps made by county assessors. Power lines depicted on aerial photography will fall inside the easement drawn on the map. Indicated gaps and overlaps between property descriptions will really exist. The stakeholder meetings planned for this year are the first step to a cadastral layer that really works.
