Missouri Mappers Association: Legislative Committee Report

The 97th General Assembly – First Regular Session is underway. Many bills were filed prior to the session starting.

So far it is fairly quiet as far as bills filed pertaining to the assessment process or anything that looks like it may have an effect on cadastral mapping or GIS. Nor have I read anything that looks like it may have an effect on other local governments.

House Bill (HB) 32 filed by Representative Guernesy would require the State Tax Commission (STC) to use an assessor's property assessment method in a an appeal to the STC, instead of requiring independent fee appraisals.

House Joint Resolution (HJR) 3 filed by Representative Elmer – proposes a constitutional amendment to exempt certain personal property from taxation while active duty military personnel are stationed outside the US.

HB 147 filed by Representative Davis proposes to give more procedural protection to taxpayers In any county pertaining to residential property tax assessments.

On the Senate side

Senate Bill (SB) 39 filed by Senator Sifton will reauthorize the Missouri Homestead Preservation tax credit.

The Missouri Legislature is just beginning to wake up from it's winter's nap, so there is still plenty of time for things to warm up in Jefferson City.

I encourage each member of Missouri Mappers Association to contact your local House Representative or Senator and let them know your concerns. You would be surprised by how few people contact their elected officials in Jefferson City and let them know your concerns about any legislation or other matters.
