Ken Olive reported at the last MMA Board meeting that HB 537 has been introduced. This bill is being sponsored by former Pettis County Assessor, Representative Dean Dohrman. The summary from http://www.house.mo.gov/billtracking/bills151/sumpdf/HB0537l.pdf is as follows:

HB 537 – GEOGRAPHIC RECORDS SPONSOR: Dohrman This bill allows a computer-assisted mass appraisal (CAMA) system to be used by a county assessor, except in charter counties, to assist in the performance of his or her duties and in estimating property value. The bill also allows the county assessor or communities to restrict access to geographic information associated with a CAMA system.

MSDIS Monthly (December) Report to the MGISAC – December 30, 2014 Mark Duewell, MSDIS Program Manager

1. MSDIS Servers:

Because of the new MST (Rolla) site's availability as a backup - our hands are freed to begin the reconfiguration of the TC server's storage. The end result will eventually be a single storage solution that NN and TC will draw from. That same full solution will be replicated at MST. TC is currently down to begin stripping its drives for the final solution.

- 2. MSDIS will be a "Silver" level exhibitor at MOGISCON2015. MSDIS staff (Tim, Tom and myself) are teaching a number of short courses and\or presenting at a number of sessions. MSDIS is in the process of purchasing an 8' conference display booth.
- 3. The Broadband "Tall Structures" Project:

FlyMidMo Imagery Consortium Tours Surdex, Melissa Johnson, GISP

A group of 10 who represented some of the 7 counties participating in the 2015 FlyMidMo Imagery Consortium traveled to Chesterfield to kick off our imagery project with a tour of Surdex Corporation. Surdex was one of the pre-approved vendors from the Missouri State Contract. The use of the State Contract along with the large area we were able to fly allowed our consortium to save considerably on this flight.

Our host Tim Donze led the tour. He introduced us to our project manager Wade Williams who took us through the flight lines, controls, online QC tools and our timeline for getting the project completed. He also answered any questions we had.

The group then toured the facility starting with the various computer stations where we were able to see how the imagery is processed using several high tech tools, some of which Surdex develops in-house. They showed how they can track the planes in the air from their smartphones and computers. Once imagery is col-

lected they will process it balancing out for contrast and color, check to make sure seams are in the best location, and many other checks before sending the images to the client for QC.

They demo'd their tools for processing LiDAR (Light Detection and Ranging) and how they create the "bare earth" raster that can be used to create contours.

We then visited the hangar where we were able to view several planes undergoing routine maintenance. The planes must be regularly maintained which sometimes means disassembling and putting

them back together. To cap it off we were able to see their new UAV (Unmanned Aerial Vehicle).

If you get the opportunity to tour this facility I recommend it!


Missouri GIS Day at the Missouri State Capital will be held on April 21st from 9—12 on the 1st floor rotunda.
