






Northwest Chapter Report




Central East Chapter Report

MDSIS Report—Thomas Vought, MSDIS Senior GIS Specialist

1 MSDIS Cloud Migration and rebuild

Since its inception in the 1990's, the mission of the Missouri Spatial Data Information Service (MSDIS) has been to create and maintain a geospatial data clearinghouse for the State of Missouri. Housed at the University of Missouri within the Department of Geography the service continually acquires vector spatial data from local, regional, state and federal sources as well as remotely sensed data such as aerial photographs, LiDAR and satellite imagery. MSDIS currently serves out over 40 Terabytes of data freely to the public. In 2018, MSDIS' data and services were migrated from our own physical servers to the Mizzou cloud. This migration was the result of a year of planning and has already helped MSDIS reduce both the workload and the overhead costs of maintaining physical hardware.

Along with our move to the cloud, we have also made changes to the look and the feel of the MSDIS website to make the data we serve more accessible to new users. Pages with duplicated information have been combined, broken links have been removed, and the old MSDIS data ftp has been replaced with the MSDIS Data Archive (http://msdis-archive.missouri.edu/archive/). Most importantly, we have put our map data server (http://msdisweb.missouri.edu/arcgis/rest/services) to greater use by deploying significantly more ESRI REST services of important vector data layers.

2 ArcGIS Online and ESRI Open Data implementation

Using the ArcGIS Online platform we have also been able to increase the ease with which users can find and download data layers. The previous LiDAR download tools have been replaced with interactive map applications powered by ArcGIS Online (http://www.msdis.missouri.edu/data/lidar/index.html) that are easier to maintain and update. We have also deployed several completely new download tools for our imagery data collection, including The Missouri Map (https://arcg.is/OqSnab), providing a single application for downloading NAIP imagery, elevation data, various DRGs, and the 2015 statewide DOQQs.





MDSIS Report—Thomas Vought, MSDIS Senior GIS Specialist (Continued)

MSDIS has retired the GeoPortal in favor of a new ESRI Open Data page (http://data-msdis.opendata.arcgis.com/). While the GeoPortal was originally designed to be a convenient way to access the entire MSDIS data catalog, users found it difficult to navigate and adding data to the platform usually required significant changes to metadata. The MSDIS Open Data platform has been designed specifically to draw attention to the newest, high-value statewide datasets that most GIS professionals are looking for and has provided an efficient way to deploy new data much faster while requiring almost no changes any existing metadata. The entire MSDIS data catalog can still be accessed through the MSDIS Data Archive.


3 Expanding MSDIS Services and Financial Security

Finally, MSDIS is actively seeking new ways to better align the clearinghouse with the goals of the University of Missouri and to expand the services that we offer. To help students become more "career ready" MSDIS and the Department of Geography are training students to help maintain the clearinghouse. In doing so, we hope to provide an opportunity for the next generation of GIS professionals to gain hand's-on experience with a variety of spatial data as well as database development and maintenance. Additionally, after teaming with the Missouri Geographic Information Systems Advisory Council (MGISAC) to revive and update the Metadata Workshop previously offered by MSDIS, we are increasing our capacity to offer training programs and workshops in GIS and Remote Sensing to interested groups around the state and working more closely with the Department of Geography to secure externally funded training-related grants.


