"MAPPING MAIN STREET" IAAO'S THIRD ANNUAL MAPPING SEMINAR July 27-28, 1987

ST. LOUIS, MISSOURI

IAAO will hold an important two-day seminar examing the basic elements of a complete, current, and accurate set of cadastral maps, their significance, what purchashers need to know in order to acquire them confidently, and how to compile them into a cadaster on July 27 and 28, 1987, at the Adam's Mark Hotel in downtown St. Louis. The seminar will include a four-hour drafting session, as well as a seminar session for administrators that will include contracting procedure. Aerial photography, drafting problems in mapping, land descriptions and map maintenance are a few of the topics that will be addressed by seven senior cadastral mapping specialists.

IAAO has designed this seminar for everyone who wants to improve the quality of property ownership maps in rural, non-metropolitan urban, and metropolitan areas alike. Those who attend the 1987 Mapping Seminar will earn ten hours of IAAO recertification credit, and equivalent credit from other organizations.

NEW OFFICERS AND CHAIRPERSONS

As the annual meeting draws near, so does the time for the election of new officers and the appointment of new committee chairpersons. Our association, like all other organizations, needs the input of its members to help plan for the future. It is good for the association to have this change of officers every year to allow new people with new ideas to be involved in the decisions effecting us. We have been fortunate in the past with the officers and chairpersons who worked to get the association started and those who worked to keep it going.

You may wonder what is involved in being an officer in MMA so

below is a description of each office:

President: The President shall be the Chairperson, and preside at all general association meetings and executive committee meetings, or designate the Vice President of in his or her absence another member of Executive Committee. The President shall have power to appoint regular or special committees as he or she may deem necessary.

Vice President: The Vice President shall exercise all the powers and duties of the President during his or her absence or inability to act and shall perform such other duties as may be assigned by the Executive Committee. The Vice President shall also act as coordinator of the Standing Committee.

Secretary: The Secretary shall keep a roll of all members of the Association and a true up-to-date record of all proceedings of the Association and meetings of the Executive Committee, subject to the inspection and approval of the Executive Committee, which shall be turned over to his or her immediate successor in office.

Treasurer: The Treasurer shall be the chief financial agent of the Association and shall exercise such authority and perform such duties as may be prescribed by the Executive Committee. The Treasurer shall have custody of all funds, securities and legal instruments of the Association and shall be responsible for their safekeeping. To this end the Treasurer may, subject the approval of the Executive Committee, determine the place and manner of depositing and safekeeping of such funds, securities and legal instruments. A correct account of all receipts and disbursements must be kept and a complete up-to-date report submitted at each annual meeting. The Executive committee shall have full right to examine and or cause an audit to be made at any time.

The officers meet five times a year, once at the annual meeting and then about every three months throughout the year. The meetings usually last about two to three hours and centrally located from all the officers. Of course the officers have work they do at home but usually that can be easily kept up with. MAPPING COURSE OFFERED







"LITE TABLE" LEGAL DESCRIPTION

The following legal description was found in the Recorder's office in Taney County, MO. Book 278, page 1230 by Timothy J. Houtchens, Sr., mapper, Taney County Assessors office.

All of the southeast quarter of the northwest quarter of Section 35, Township 22, Range 17, EXCEPT about 3/4 acre off the northwest corner of said 40 acres.

About three-fourths (¾) of one acre off of the southeast corner of the SW¼ of the NW¼ of Section 35, Township 22, Range 17, described as follows: Beginning in a hollow about 14 yards west of a cave on the north line, thence west of south crossing the line dividing the SW¼ NW¼ and the SE¼ NW¼ of Section 35 at a point about half way of corners and on in said direction by two locust trees and on to the mouth of a spring branch to the south line of the said SW¼ NW¼, thence east to southeast corner of Silv NW¼ Section 35, thence north to northeast corner of said SW¼ NW¼, thence west to place of beginning.
