EDUCATION COMMITTEE

The Education committee met on December 13, 1986 and discussed plans for upcoming year. The committee has set three goals for the year. The first is to develop a workshop

on aerial photography, the second is to present IAAO Course 6 and the third is to begin planning for a manual on tax mapping

The workshop on aerial photography is tentatively scheduled for late April or early May. Plans are for a one and one half day program addressing flight planning, area selection, costs and contracting. A pamphlet will be mailed to all members in the next few weeks providing details on date, location, program and registration requirements.

Initial arrangements have been made to present the International Association of Assessing Officers Course 6, Fundamentals of Mapping. It will be given the third week of October, 1987. George Donatella, PMM has agreed to take time from his busy schedule and will handle the instructional duties. The course will be held either in Springfield or Columbia, Missouri. If you have a preference for either location please contact Bob Norris at 314-751-1735 or 314-635-7423. All details should be finalized by the next newsletter, and a pamphlet will be mailed prior to the annual meeting in August.

The development of a manual on tax mapping will probably be the most challenging project this committee will undertake. Its success will be dependent upon the involvement of the association membership. The committee needs your help in order to put together a manual that will benefit and be of use to us all. If there are topics you wish to see addressed or if you would like to contribute by writing a section(s) please submit your ideas to the education committee. At present the timeframe for development of the manual is to receive suggested outlines for the manual. During the March committee meeting a tentative outline will be adopted. The next step will be to contact members who are knowledgeable and willing to begin drafting the initial sections. Hopefully be early to mid-summer the initial sections will be drafted and ready for editing. Editing and illustration should be complete by fall. If this schedule holds, then printing should be completed in the fall and the manual should be ready for delivery by late fall or early winter.
