PROPOSED REVISIONS TO THE CONSTITUTION

Missouri Mappers Association is a young organization that is changing to better suit the needs of its members. The executive committee is going to propose two changes to the MMA Constitution at our annual meeting, August 11, 12, and 13.

One of the changes will involve the duties of the Directors which had been overlooked in our original constitution. The other change involves the length of term and the time the Directors are elected.

Our MMA Constitution that was revised at our annual meeting in August of 1987 states in Article III "Officers":

Section 1—Selection: At each annual meeting there will be elected for a term of one (1) year, by the membership in good standing who are present, a President, a Vice President, a Secretary, a Treasurer, and two Directors.

We will propose to change this section of the constitution to state:

Section 1: Selection of each annual meeting there shall be elected for a term of one (1) year, by the membership in good standing who are present, a President, a Vice President, a Secretary, a Treasurer. Two (2) Directors shall be elected for a term of two (2) years each, by the membership in good standing who are present, with one (1) Director being elected each year. For 1988 only, one (1) Director shall be elected for a two (2) year term and one (1) Director shall be elected for a one (1) year term. One (1) Director shall be elected each year thereafter so that the

The Executive Committee is made up of the President, Vice President, Secretary, Treasurer, two Directors, and the Immediate Past President. The purpose of the proposed revision is to allow for a two year term for each Director so that each year there will be at least two members of the Executive Committee who were involved with it the previous year—the Immediate Past President and one of the Directors. This will provide better continuity to the programs and goals of the Association so that work started by one Executive Committee may be carried on by the next.

terms of the Directors shall be staggered.

We will need to elect one Director for a two year term and one Director for a one year term in order to get the staggered elections started.

The second proposed change will simply add the duties of the office of Directors in Article IV of the constitution. There is no section there now for the Directors, but we would like to add the following:

Section 5—Directors: The Directors shall help guide the Association to achieve its objectives by their involvement in the Executive Committee. They shall serve on the Executive Committee with the same voting rights as the other officers.

The proposed revisions have been submitted to the Executive Committee 60 days in advance of the annual meeting and are being submitted to all the members in this newsletter prior to the annual meeting as required be Article VII Sections 1 and 2 of the MMA Constitution.

THE KANSAS CITY METRO CONTROL SYSTEM

Horizontal and vertical control is needed in many areas of the country for the development of a local geographic information system. Some of the systems that are being developed rely on photogrammertrically produced mapping that uses the 71/2 minute USGS Map as a control base. This control is not monumented on the ground and the local surveyor cannot generally use it as either part of his land or engineering survey work. Thus, ground measurements are not directly related to the mapping or the resultant GIS. The best way to provide the control necessary in an urban area for the development of geographic information systems is to provide adequate horizontal and vertical control at approximately two mile spacing. This spacing satisfies the basic needs for development of geographic information systems. This control spacing is adequate for good photogrammetric mapping in a local area, and it also provides the control that surveyors and engineers need for their surveys. The two mile spacing is an adequate spacing comparable with today's surveying and mapping technology and within the realm of current budgetary constraints for both the establishment and maintenance of a control system.

The governmental units in the metropolitan Kansas City area recognize the growing need for a high quality horizontal or vertical control network. Many of these governmental units are in the process of designing or implementing geographic information systems. As a result of this increased utilization, the Kansas City Metropolitan Control System was developed. It represents a cooperative effort between city, county, and state government, along with the private professional land surveying industry. The area of the project emcompasses the Counties of Clay, Platte, and Jackson in the State of Missouri, and Wyandotte and Johnson Counties in the State of Kansas. When completed, this network will provide a framework for all surveys and geographic information systems in those five counties. The system is on national geodetic control datum so that it is related to a national framework. Each state will be on the same datum; therefore, the state line will not cause discontinuity in geographic data.

Even though the scope of this project is fairly large, it was never envisioned to be a massive drain on state or local funds. The project has been designed for implementation over a ten year period. In actuality, it has gone much faster in the first two years of its operation than initially planned. It appears to be one of the largest cooperative efforts of its size in the United States. After only two years, the control system consists of approximately 120 points. These points are already available to many of the entities in the metropolitan Kansas City area. The City of Kansas City and Jackson County now require the surveyor and engineer to utilize this system for all their survey work thus assuring the city and county governments that new surveys will fit into their developing data bases.

One of the unique features of this project has been the cooperative effort between the city, county, state, and the local surveyor. Each has a stake in the final utilization of this system, and each has taken an active part in its establishment. City and county governments have assisted financially along with the state in development of these stations. The state has provided the coordinated effort in the design of the system and the final publishing and maintenance of the stations. The local surveyors have responded by providing survey work and monumentation.

This project and its final implementation can serve as a model to many other communities across the State of Missouri and the United States. It is a model in cooperative effort between the responsible parties in the development and preservation of land survey information.

REGIONAL WORKSHOPS


