Proposed Constitution Changes

Article III, Section 1 of the Constitution of the Missouri Mappers Association currently reads as follows:

ARTICLE III

"Officers"

Section 1 Selection: At each annual meting there shall be elected for a term of one (1) year, by the membership in good standing who are present, a President, a Vice President, a Secretary and a Treasurer. Two (2) Directors shall be elected for a term of two (2) years each, by the membership in good standing who are present, with one (1) Director being elected each year. Beginning in 1988, one (1) Director shall be elected for the full two (2) year term and one (1) Director shall be elected for a half, one (1) year term. One Director shall be elected each year, thereafter, so that the terms of the Directors shall be staggered.

The proposed change to be presented to the general membership at the 1993 Mappers Conference is as follows:

ARTICLE III

"Officers"

MISSOURI MAPPERS ASSOCIATION CADD COMMITTEE

PRO-FORMA STATEMENT

Over the last ten years the use of computer-aided drafting and design (CADD) in cartography has become standard. The development of software programs tailored specifically for mapping production and interpretation coupled with more affordable hardware makes CADD mapping a viable alternative to the more traditional forms of mapping.

At the annual meeting of the Missouri Mapping Association (MMA) last August a group of members, recognizing the need to address and utilize new technologies in the cartographic profession, met to discuss the possibility of forming a permanent committee within the Association dedicated to computerized mapping and land information systems.

PURPOSE & ROLE

The role of a CADD committee within the structure of the Missouri Mapping Association would be to endorse the education and use of computer-aided mapping and information systems throughout the various public and private agencies that create, maintain, and access cartographic products and geographically referenced information. The CADD committee would also promote:

- The sharing of experience and technique in the CADD environment among members of the Association.
- Training programs and seminars which focus on the use of computers and computerized data in the cartographic profession.
- Technical standards/formats which would facilitate easy exchange of graphic and nongraphic digital data between agencies throughout the state.
- The creation of a Professional Missouri Mapper (PMM) CADD designation emphasizing digital cartographic techniques.
- The creation of a state-wide clearing house for geographic information which could be easily updated and accessed by agencies throughout the state.

COMMITTEE STRUCTURE

Since the purpose of this group is the open exchange of information and ideas it is proposed that the CADD committee be formed along the lines of a working group; any member having an interest in CADD mapping or information systems is welcome to be part of the group, and should contact Dan Roe at Miller & Associates.


Christy Linhart asked if membership in the West Central District Chapter would provide her points to retain her PMM. The Executive Board will be approached with this question.
