"Flood!" Somehow that lacks the adrenalin response one gets with "Fire!" And yet human lives were lost. Pets, livestock and wild animals perished by the millions. Untold lifetimes of hard work were wiped out in the form of homes, businesses and farms.

"Flood!" It was really just a wet spring that forgot to stop. It marched on relentlessly for months, higher and higher, dissolving levees, chewing up dikes and sandbag barriers, w\sweeping aside all the human sweat and resolve we put into stopping it.

The Mississippi and Missouri rivers run beside or through 39 of Missouri's 114 counties. Other rivers in Missouri also flooded. We measured the flood's progress in inches per day. Inches that added up to disaster. The probability for flooding of this magnitude is once every 500 years.

Here we are, the mappers of Missouri. Many of us were called upon to document high water lines and tabulate flooded parcels. Some provided information for emergency operations, like persons' names and addresses inside an evacuation perimeter. FEMA got information from our maps and databases either directly or indirectly so victims of the flood could receive needed funds fast.

Let's come together and learn from our experiences. Let's look at how we aided our counties and how we will continue to help our counties adjust and recover in the coming months and years. Let's talk about how we can better prepare ourselves and our departments for disasters of all types. This was a "slow" disaster. Next time the disaster may be of the "fast" type: earthquake, chemical leak or nuclear accident. Let's talk about optimizing our usefulness to Emergency Management Operations in our areas.

THE 1993 ANNUAL MEETING



The Ninth Annual meeting of the Missouri Mappers Association was called to order by Sandy Estes. Debbie Cochran, President, welcomed everyone in attendance. She covered over the past year's activities and talked about the formation of two new committees, Cadd committee and Historic committee. Debbie also mentioned the two new chapter that were formed, Central East and Central West. Central East Chapter cochairperson Gary White summarized the past meetings. He talked about the different speakers and the discussions that were held. Central East also discussed future multi-county aerial flyovers to cut costs. They would welcome interest from all other Missouri counties. Central West chairperson Marty Buckner talked about the new chapter that was formed in January 1993. She mentioned that they were taking turns visiting each of their different counties' mapping departments, discussing techniques and sharing ideas.

The first speaker for the meeting Jim Matlock, of Missouri Department of Natural Resources, discussed the different programs the department was offering. One of which was on tax map overlays and how they can be made available on microfiche or a hard copy map. He suggested anyone interested in the programs make an appointment by calling his office (314)-368-2313 on any workday between the hours of 8:00 am and 4:00 pm.

Dan Roe, PMM of Miller and Associates, the second speaker of the day, discussed the PMM (Professional Missouri Mapper) designation. Dan mentioned that at the present time there are fourteen PMMs in the MMA.

He further outlined the process for certification, and also gave an overview on the requirements to maintain this designation.

Robter Meyers from the Missouri State Land Survey spoke about mapping accuracies, state and county boundaries, the remonumentation program offered by the MSLS, and GPS.

FLOOD IMPACT SYMPOSIUM

WHY?

The flood impact symposium was created because of the unusual and serious floods of the summer of 1993. Many of our counties experienced the worst disaster in modern history, and many of our mapping departments had sudden and extraordinary demands placed on them. This symposium will be a chance to share and relate how we handled special requests from emergency operations, public works inspectors, planners, family services, utility companies, F.E.M.A., and other agencies who needed maps and ownership information.

PROGRAM

This symposium will be a "mixed bag" of presentations by persons involved in flood mapping, users of flood maps, and the importance of G.I.S. data for present and future disasters. There will also be a session of roundtable discussions between local and government entities (assessors, emerg. operations personnel, mappers etc.) to address specific issues or problems that arose from the flood and to improve response for future disasters including earthquakes, tornadoes and nuclear or chemical disasters. These discussions are contingent on attendance at symposium.





Mary Ann Kaiser of Miller Management Services Inc. gave a very informative presentation on 911 at the 1993 MMA annual 911 is a very vital meeting. service to have in your county, whether it be Basic 911, where you verbally communicate your identity, location, and nature of problems, Semi Automated, where the dispatcher receives the phone number visually as well as verbal communications, or Fully Automated where the dispatcher is instantly made aware of your phone number, location, ambulance address, fire and police service, protection.

As Mappers, we can work with this program to provide locatable addresses that will enable emergency personal the fastest contact possible.

As Mary Ann said so well, "If one life is saved in your county it has been worth the time and money."

Have you got a "difficult" person on your staff? Joyce Kuhn, a professor at Longview gave Community College, fascinating, dynamic talk on "Dealing with Difficult People". She addressed major areas in her talk: your listening increasing with effectiveness, dealing frustration and rejection and finally, ways of dealing with the 5 types of difficult people in the work place.
