#### PMM CERTIFICATION EXAMINATION

The Missouri Mappers Association PMM certification examination will be schedualed for sometime in April or May of 1995. If you meet the following designation requirements, you are eligible to take the 7 hour comprehensive and subjective examination:

- 1. Have five full years of cadastral mapping experience or its equivalent.
- 2. Be engaged in the use, production, or maintenance of cadastral maps.
- 3. Attended a minimum of 30 hours of study in mapping, surveying or a closely related subject.

In order to be scheduled for the examination, you must complete a certification application and submit information verifying that you meet the requirements listed above. This information must be received by the certification committee no later than March 15, 1995. A \$25.00 Fee is also required.


