ESRI has recently released several new ArcView extension products. In addition, several additional extensions are in the works and will be released later this year.

The ArcView Internet Map Server is an out-of the-box GIS and mapping solution for publishing your ArcView GIS maps on the World Wide Web.

ArcView StreetMap is an ArcView extension product that supports nationwide (US) address geocoding and street map display. The StretMap extension includes a street and landmark database for the 50 states of the United States which is compressed onto a single CD. Given the StreetMap CD and the StreetMap extension loaded in ArcView 3.0, users will be able to geocode United States addresses and add a new type of theme called a StreetMap Theme.

ArcView Spatial Analyst introduces a broad range of powerful new spatial modeling and analysis features previously not available to desktop users. This new extension allows you to create, query, map and analyze cell-based raster data and to perform integrated vector-raster analysis.

The ArcView Network Analyst extension enables users to solve a variety of problems using geographic networks (i.e., streets, highways, rivers, pipelines, electric lines, etc.) such as finding the most efficient travel route, generating travel directions, finding the closest facility, or defining service areas based on travel time.

George Yerion, LS is Vice President of Computer A.C.E.S., Inc., a CAD/GIS consulting firm based in St. Louis. For the past four years, Computer A.C.E.S. has helped Civil Engineering and Surveying firms become more productive through application of the appropriate technological tools for their businesses. He has 20 years of experience with COGO and other computer-based mapping tools.

Robert Meyers, PE, LS, is owner of Land Related Technology, a consulting land surveying firm. He recently retired from his position as the Missouri State Land Surveyor and Program Director of the Land Survey Program of the Department of Natural Resources Division of Geology and Land Survey. In this role, he was responsible for the state-wide Land Records Repository, preservation and remonumentation of original government survey corners, maintenance and densification of horizontal and vertical control network stations, and establishing standards for land surveys and geodetic control surveys in Missouri. Prior to working for DNR, he spent 25 years in private practice as a land surveyor and engineer.

Lienholder Has Right In Third Offering Sale

The Missouri Supreme Court has ruled that the rights of a lienholder are protected in tax sales, even when the property is offered and sold in the third year. Property was sold at a third offering in St. Louis City, following publication of notice, for \$3,703. Prior notice of the sale had not been sent to any lienholder. After the sale, the buyer sent a letter to a lienholder, who held a \$21,378 lien, telling them they had 90 days to redeem the property. The collector refused lienholder's payment of \$3,869, assuming that no redemption is allowed following the third offering for delinquent taxes. The Court, in M&P Enterprises, Inc. V.s. Transamerica Financial Services, et. Al., No.79108. April 29, 1997, held that there is a right of redemption on a third offering of delinquent land and because no notice was given, the outstanding lien was still outstanding and a valid debt.

A Typical Project for Orthophoto Base Maps

Step 8--Image Mosaicking. All images will be merged to eliminate mismatches between tiles or map sheets and create a seamless County-wide base map. This procedure is very important for those who are moving into an automated mapping or GIS mapping system. The brightness and contrast will be checked and radially displaced features such as buildings will be checked to ensure that the buildings are not distorted where orthophoto tiles are edge-matched.

Step 9—Accuracy and Scale Check. Each digital orthophoto image will be checked for accuracy on screen. All control points (surveyed photo-identifiable points) that are visible on the aerial photography will be visited on screen and the x, y coordinates will be displayed. This information will be cross-referenced with the x, y information provided by the original ground survey.

This quality control procedure ensures that the orthophoto correction is carried out successfully. If the orthophoto doesn't meet the required standards at this stage, the rectification process should be preformed again.

Step 10-Paper Check Plots or Final Mylar plots.

A paper check plot can be generated to ensure that the orthophoto map covers the same geographic area that the parcel map covers. The digital orthophoto file will be saved on a CD-ROM suitable for use in a GIS or CADD software environment.

On many occasions the final mylars are still needed, even if computer mapping is planned. The mylars will be plotted on a high resolution film writer. The surrounding title block information will be registered to the orthophoto image plot and the same orientation and mapping location will be matched to the original base mapping. This will enable the parcel map overlay to register to the new map for blueline composites.

Step 11--Future Map Updates.

Individual map sheets can be updated without re-flying and updating all map sheets. New photography can be merged into the digital orthophoto database and the accuracy, scale and image tone can be matched to the older photography in the areas that have not changed. This procedure will allow the County to budget small amounts annually or bi-annually to keep pace with the growth areas and avoid a large update - maintenance contract at one time.
