GIS Companies Look to "Seed" Technology in Counties

ntergraph Corp. and the National Association of Counties have joined forces to help smaller county governments launch their own geographic information systems. At NACo's annual conference in Portland, Oregon last month, executives unveiled a free GIS "Starter Kit" to sell the benefits of the technology to county administrators.

Not to be outdone, Intergraph rival Environmental Research Institute, Inc. launched a \$2.4 million grant program to help seed GIS projects at local agencies.

The Intergraph/NACo kit includes the latest version of Intergraph's GeoMedia software as well as basic GIS data specific to the various counties that apply for the kit, initial software training and ongoing service support.

GeoMedia is Microsoft Corp. /indows-based GIS software that provides access to spatial database management systems.

In exchange for the kits, Intergraph is asking local governments to designate high-level officials to attend GeoMedia training sessions. Intergraph believes both the kits and the training may help implant the technology at the local level.

Speaking at the NACo conference, outgoing NACo's president Randy Johnson said there is some awareness of GIS among technical people in county government but little among county administrators and other executives – the very people who might find the technology most useful in their decision-making.

The kit is seen as a way of getting these people "over the hump" of starting with GIS, Johnson said.

"If they can see report information graphically on a map, it's so much easier for them to see what is going on and to see trends occurring over time," Johnson said. "GIS is also a good way to make raw information available to the public."

Tom Clemons, Intergraph's director of industry sales, said "We are trying to overcome some of the hesitance among the counties in their use of GIS." Clemons spoke of URISA, the annual conference of the Urban and Regional Information Systems Association, taking place at the same time in Charlotte, North Carolina.

The kits will contain data specific to each county that qualifies for the program. "The local data will be able to support three to four applications aimed at problem-solving in areas such as economic develop-

ment, redistricting of political boundaries and emergency management," he said.

Intergraph, based in Huntsville, Alabama, estimated the kits are worth \$10,000 each and could reach more than 1,700 counties, for a total value of more than \$17 million.

Under ESRI's program, which the company is calling a "Local Government Start-Up Grant," cities and counties will be provided copies of its ARC/INFO, ArcView GIS and MapObjects Internet Starter, including templates to generate local applications. "In return, we are asking local governments to build and share these datasheets," according to Chrisopher Thomas, ESRI's state and local government solutions manager, who also spoke at URISA.

Through the program, ESRI will push local governments to generate and exchange datasets that are compliant with Framework, a federal program designed to help develop a National Spatial Data Infrastructure.

he goal of this program is to foster and support the integration of GIS software in local government. Software and training grants totaling \$2.4 million will be awarded to local governments within the United States.

Program Description

The ESRI Local Government Startup Grant Program was established to provide assistance to local government agencies with the establishment of organization wide GIS projects; provide software for the establishment of parcel, street right-of-way, and street centerline information; and establish data sharing. The grant program consists of a \$2.4 million GIS investment program. ESRI will provide software and training to a total of 100 government agencies meeting the requirements of an eligible government organization. Grant recipients will receive the following:

- 1.One copy of ARC/INFO for Windows NT
- 2.One copy of ArcView GIS
- 3. One copy of MapObjects IMS
- 4 MapObjects Internet Starter Application
 - a. General Map Utility
 - b. Property Information Utility
 - c. Event Notification Utility
 - d. Site Selection Utility
 - e. Demographic Utility
- 5.ArcExplorer
- 6.Links to ArcData Online Program
- 7.One Introduction to ArcView GIS Class via ESRI's Virtual Campus

Eligibility

The following local government agencies are eligible for the ESRI Local Government Start-up Grant Program:

Councils of Governments (COGs)
Metropolitan Planning Organizations
(MPOs)
County Governments
City Governments

Priority is given to organizations that do one or more of the following:

Demonstrate collaborative efforts with multiple departments

- 2. Projects that promote public access to GIS databases
- Projects that communicate innovative government through the use of GIS

Provisions

To meet the goals of the Local Government Start-up Grant, recipients must agree to develop GIS framework databases. These framework data must include:

- 1. Parcel/Cadastral base
- 2. Street right-of-way base
- 3. Street centerline base



Grant recipients must also agree to make available a minimum of one copy of the three designated framework databases to all government agencies for no more than the cost of reproduction media. Performance Reporting Grant recipients agree to provide to ESRI a performance report on the status of the grant-funded project 12 months after the grant award.

Additional Information

The grant program is limited to one grant per eligible government organization. Grants are intended to be awarded to organizations that do not currently use ESRI software. Award Period: August 1, 1998, to February 28, 1999.

Date of Notification: Grant awards will be announced in three phases. Applications received during the program will remain eligible throughout the entire award period. There is no need to reapply. All recipients must agree to have their organization's name used in ESRI press releases and direct mail campaigns.

Notification of grant awards will be made on the following dates:

Phase I – October 1, 1998 Phase II – December 1, 1998 Phase III – February 28, 1999

Procedure for Applying

Applications must be received no later than 5:00 p.m., February 1, 1999. Each applicant must provide a typewritten response to each of the following in the format requested. Items D-I must be submitted on a maximum of three pages, double-spaced.


