NOTES FROM THE PRESIDENT

Our organization showed the stuff we are made of at the 6th annual MOGIS (Missouri G.I.S.) conference in Columbia on March 26-28. We participated as a nonprofit vendor in the exhibit area. This was located in the Expo Center adjacent to the Holiday Inn Executive Center where we hold our Annual Meetings. This convention is probably best described as a cross between our MMA annual meeting and the 6-state Mid-America GIS convention which is held every two years. The MOGIS conferences are also held alternating years with the 6-state event. At our display, we had some working samples of Cadastral (property) maps and aerial photographs from around the state as well as some membership maps and organization information. The display looked very nice - thanks to the City Utilities of Springfield folks who obtained the display hardware and arrived early Monday to set it up.

In addition to manning the booth, I was invited to give a brief talk about our organization at the users group breakout session and further promote our organization. After hearing the backgrounds of some of the other user groups, I realized that our group has been around a long time (since 1984). Many of these GIS software specific organizations have only been around a year or two. I mentioned that our group was formed in the days of pure manual mapping, when GIS was a nonexistent acronym.

Many people inquired about our organization and some of the other vendors expressed an interest in exhibiting or speaking at our conventions in the future. Jennifer Peterson of City Utilities in Springfield was a moderator of the event and made sure an MMA application was in the handout packets for every attendee. We also had copies of the most recent newsletter available as well as workshop handouts, a promotional giveaway, and a prize drawing of some donated items.

I would like to again thank those who submitted materials for the display and also to those MMA

members who manned the booth to give me a break or just chat during the slow traffic times. We will discuss at the next Board Meeting making plans for displays at upcoming MOGIS and Mid-America GIS conferences.

NOTE - The 2002 Mid-America GIS conference is scheduled for April 16-18 in Kansas City, MO.

SOUTHWEST CHAPTER

February 22, 2001, the Southwest Chapter meeting was hosted by City Utilities of Springfield, GIS group. Jennifer Peterson, President, opened the meeting and welcomed members of the newly formed Ozark GIS group. There was a short business meeting, and we discussed meeting times and dates. We then had some demos from members of City Utilities. Gilbert Guevara talked about electric detail maps and what information goes on the maps. He gave a brief talk on the electric territory and coverage areas of the electric department. Richard Brown gave a talk and demo on the making of the Electric Wall Map and what it takes to make the map. This map shows the whole electric coverage area of the Utility. The Electric Department used this map during outages and storms to keep track of where the outages are, and where to send the crews to fix the problems. Melissa Lawson talked about Facility Management and showed some drawings that she is currently working on. These drawings are used to track information about the different facilities - (such as when the facilities are being remodeled, or when minor changes are being done at each facility). Kyle Gjeruldsen of CADD Solutions gave a talk and demo on information about City Utilities intranet maps.



Congratulations to all of them.


