### LEGISLATIVE COMMITTEE REPORT

This was not a very good year for assessors in the General Assembly, so consequently it was not a very good year for mappers. Our technology bill made it out of committee in both houses, but the bill was never put on the calendar. The funding for parcel reimbursement from the state has been cut from 18 million to 16 million. The problems in St. Louis County had a profound effect on the mood of legislators toward the whose assessment process. The good news is that of the 70 plus bills introduced having to do with the assessment process, only one passed. It looks like the only county that will be adversely effected will be St. Louis.

As we look forward to next year, we will have approximately 1/3 of the General Assembly that will be new, because of term limits. This is going to be a challenge, but I feel we have a good chance to get some type of funding for technology through next year. The letters from the mappers were great. I had several legislators tell me they had received letters from the membership. This type of proactive display of support is what gets the attention of the legislature.


