#### **IAAO CMS Designation**

The International Association of Assessing Officer's (IAAO) Cadastral Mapping Specialist (CMS) professional designation can set you apart from your peers as an expert in land records and your county's cadastre.

The critical difference between an expert and a non-expert is not information but understanding. A non-expert is constrained in their efforts and thus success by a fixed and usually limited knowledge range. By contrast, an expert, because of their fundamental understanding of the specific principles and techniques, has the skills, knowledge, and adaptability to succeed. Your knowledge and application of these principles classifies you to be the expert in this field of study or, as Webster defines it: a professional.

The CMS professional designation is earned by individuals knowledgeable about land records. The term "land records" means different things to different people. Strictly defined, it means records dealing with, or related to, land. IAAO's mapping designation provides the designee an understanding of graphically drawing, and the legal precepts of, land records.

Each record, be it a deed, survey plat, or another instrument of property conveyance, is subject to interpretation. Some are written correctly and clearly define the author's intention, whereas some are written poorly and incorrectly state their intention. Nonetheless, they all have meaning and demand consideration.

All of the IAAO mapping curriculum courses prepare the CMS designee to be a professional in the interpretation and administration of the county cadastre, defined as "the official statement of quantity and value of real property in any district made to justly apportion the taxes payable on such property."

As a CMS designee, you will be able to apply the proper and accepted business practices to maintain your jurisdiction's cadastre.


I look forward to the next phase of archiving our MMA history.


