

Mrs. Hanaway was named one of the Missouri Lawyers of the Year by Missouri Lawyers Weekly and has been recognized as one of the St. Louis Business Journal's "40 Under 40" in addition to being named by the Journal as a "Leader to Watch". The Associated Industries of Missouri recently presented her with the Voice of Missouri Business Award. Other Awards she has received are the 2001 Health Policy Leadership Award from the Missouri Hospital Association, 2002 and 2001 Lewis & Clark Statesman Award from St. Louis Regional Chamber & Growth Association, 2002 Spirit of Enterprise Award from the Missouri Chamber of Commerce and Industry, Missouri Bar Legislative Award, and the SSM Cardinal Glennon Children's Hospital Outstanding Child Advocate Honoree.

She earned her law degree from Catholic University of America and worked in the law firm of Peper, Martin, Jensen, Maichel & Hetlage. 




