

Keynote Speaker



The Missouri Mappers Association would like to welcome **Jim Harlan** to the 21st Annual Conference!

Jim is Senior Research Specialist and Assistant Program Director for the Geographic Resources Center, Department of Geography, University of Missouri-Columbia. He is responsible for the teaching of Geographic Information Systems, Cartography, and Remote Sensing classes at the University. He was the project director for the Lewis and Clark Historic Landscape Project that successfully geo-referenced and mapped the early 19th century Mississippi and Missouri Rivers

along with their surrounding cultural and natural landscapes. He currently is project director of the *Missouri Historic Land Survey Project* that is nearing completion which is a digital recreation of the historic pre-settlement landscapes of the entire state of Missouri. Jim is co-author of *Atlas of Lewis and Clark in Missouri* (University of Missouri Press, Nov. 2003).

Jim is a native Missourian raised in Randolph County in the little town of Cairo. Since early boyhood, Jim has been intensely interested in maps, geography, and history. This interest has served him well throughout his various life experiences including multiple overseas tours with the U.S. Army, research work in Panama with the Kuna Indians, and this latest historical geography work on early Missouri landscapes.

Jim is going to discuss the *Missouri Historic Land Survey Project* which is a 10 year project that involves the U.S. General Land Office (GLO) surveys which covered 65,370 square miles of Missouri's total land surface of 69,697 square miles with the remainder in pre-U.S. (Spanish and French) land grants. When completed this summer, this project will have converted 660 volumes or over 200,000 pages of hand-written notes describing the early territory of Missouri into one ready-access database. The varied information from these notes was written by



ordinary human-beings for ordinary human-beings in the late eighteenth and early nineteenth centuries in pursuit of understanding and organizing Upper Louisiana and promoting its rapid settlement in the Jeffersonian ideal. Such human effort is of major importance in understanding the history of the settlement of the United States. When coupled with early French, Spanish, and U.S. exploration documents, such as the Lewis and Clark Journals, we are provided with a better understanding of the structure, composition and ecological processes of our native ecosystems before they were altered by modern human activities. Importantly, this historical geography should greatly increase our capabilities to more thoroughly understand the morphology of the Missouri landscape where nature is inclusive of human interaction with the land.

Workshop Descriptions & Speaker Bios

"Introduction To Drawing and Plotting in AutoDesk Map 2006" Workshop, Jerry Bartels, Seiler Instrument, Requirement: Basic Computer Skills Required

This session will provide registrants with an introduction to creating cadastral maps using Autodesk's Map 3D 2006 software. The session will be presented in a "work-flow" format rather than a traditional "feature by feature" discussion. Jerry Bartels who has over 15 years experience working in areas relating to civil engineering, surveying and mapping will be the instructor. He will begin by walking the registrants through the process of quickly creating and editing accurate parcel data followed by exploring the various GIS tools available to enhance these parcels and begin the process of creating a GIS. He will conclude the session by walking the participants through the process of outputting the newly created cadastral information using several plotting options available in Map 3D 2006.

"Using Trimble Handhelds to Map The Resort of Port Arrowhead" Workshop, Jerry Bartels, Tom Stone, Steve Tomps, Seiler Instrument, Requirement: None

Participants will go outside with the Seiler Instrument representatives who will walk participants through the latest technology that allows mapping to take place out in the field using GPS technology. The participants will assist the representatives in collecting geographic information in a specific area at The Resort of Port Arrowhead such as the putt putt course or the dock area. She recently spent a month in Indonesia as a GISCorps Volunteer assisting the UN Joint Logistics Committee with GIS activities relating to the tsunami relief effort.

"Lines, Tangents and Bearings...Oh My!: Understanding Legal Descriptions" Workshop Mark Dupree, CMS, The Sidwell Company, Instruments and Handouts Will Be Provided, Registrations Must Bring Calculators, Requirement: None

Have you ever found yourself working on a legal description mumbling "There is no place like home, there is no place like home" while clinking your heels together? This workshop is for people who have a basic understanding of legal descriptions and those working at an intermediate level that could use some practice. Registrants will have a better understanding how to use scales, protractors and land compasses along with tips for measuring and converting dimensions. The instruction will also be reviewing the Public Land Survey System and metes and bound descriptions.

Mark Dupree has 18 years experience in the cadastral mapping and GIS industry and is an IAAO Certified Mapping Specialist. He is authorized to teach the IAAO 600 Course and has worked at The Sidwell Company and ESRI. Conference Session Descriptions & Speaker Bios

10:00 A.M. - 10:30 A.M. "GIS Project Management: Considerations for Small and Medium Sized Municipalities," Kevin Hill, Lead GIS Technician, City of St. Peters

Kevin has worked for the past four years at the City of St. Peters. Previously, he implemented GIS for Newport, Oregon. He holds a B.S. degree in natural resource management and an M.S. in environmental and resource sciences.

In today's world of tight budgets its important to maximize the return any local government makes in GIS technologies. One way of doing this is to follow good project management techniques; especially in the context of an enterprise GIS where you need to balance the demands of multiple departments. But the question often is, what are the best practices for managing a local government's GIS? The environment is often much different from what you'll find in private industry. In his presentation, Kevin will cover the different project management techniques that have been successful in implementing an enterprise GIS using Intergraph software products. Additionally, contrasts will be made with more mainstream project management practices along with other pitfalls that should be avoided.

10:50 A.M. – 11:20 A.M. "Moving from Pen and Ink Mapping to GIS at Jackson County," Stephen Marsh, Jackson County

Stephen L. Marsh is the Director of the Jackson County Geographic Information Systems Department. He has a BA and MA in Geography from the University of Missouri and has been involved with GIS technology for 13 years. At Jackson County, he manages a department of GIS professionals whose primary responsibilities include, land record maintenance, creation and implementation of Internet mapping sites, and data management for Public Works and Parks. Steve is active in the Kansas City ArcINFO Users Group, the Missouri GIS Advisory Committee, and the MidAmerica GIS Consortium.

This session is about a common perception that larger counties tend to be more advanced. That is not always the case. Up until 2002 Jackson County was still working on over 1400 individual map files, and hand writing thousands of pages of documents to create and maintain parcels. In the last 2 years, Jackson County has made huge strides in eliminating paper, and modernizing processes. This presentation will cover the development of a seamless SDE database, and other modernizations while maintaining the creation of over 3000 parcels a year.

11:40 A.M. – 12:10 P.M. "Grant Writing for GIS Development," Mark Duewell, Missouri Spatial Data Information Services

Mark was the co-PI for the Missouri 2005 National Map Cooperative Agreement Program awarded last August, he authored and coordinate that program. In addition, Mark has written several successful GIS portions of major Health and Senior Service grants (namely Homeland Security, Bio-Terrorism and Environmental) while performing his duties as the Missouri Department of Health and Senior Service's GIS Manager. He moved to UMC's Missouri Spatial Data Information Service in November of 2003 and has since become the MSDIS Program Manager.

Tony is going to discuss the development of the NSGIC, its purpose and goals as an organization and their main purpose of ensuring intelligent maps and databases are established to make government and private sector entities more informed so they make better decisions. Some issues NSGIS focuses on include homeland security, emergency management, economic development, health and human services and environment protection management.

"Cost Effective Countywide Digital Orthophotography," Steve Kasten, Surdex Corporation

The USDA is currently collecting summer-time aerial photography over the State of Missouri in support of the National Agriculture Imagery Program whose primary purpose is documenting agricultural compliance. In the hope of reducing the overall cost of the program, the USDA is allowing contractors in the program to sell enhanced products. Surdex has collected aerial photography over the entire state of Missouri for each of the last three years as part of this program. Surdex has Countywide 400-scale digital orthophotography available for every County in Missouri. This presentation will focus on the resolution of data that is available and the costs associated with delivery.

Mr. Kasten is an ASPRS Certified Photogrammetrist and a licensed Land Surveyor. Mr. Kasten has worked in the photogrammetry industry for 22 years. 


