# innnnnnnnnnnnnnnnn KEYNOTE SPEAKER Tom Durkin **Public Education Director** Missouri Attorney General Chris Koster Tom Durkin began his career in state government in 1977 serving as the Administrative Assistant to State Senator Harry Wiggins. In January 1980, he accepted the position of Communications Coordinator for the Clerk's Office, Missouri Supreme Court. Then in 1982, Mr. Durkin relocated to New York City and later to Los Angeles where he worked in the entertainment industry as an actor for 17 years. In 1999, he was offered the opportunity to serve as the Director of the Media Focus Program at Providence High School in Burbank, California where he taught classes in media studies and literature. After spending 25 years living on both coasts, Mr. Durkin returned home to Missouri. Shortly following his inauguration in January 2009, Attorney General Chris Koster invited Tom Durkin to join his staff as the Public Education Director. As the Public Education Director, Tom Durkin has traveled extensively across the state speaking to groups on a range of topics; including ID Theft, Internet Safety and the Missouri Sunshine Law. This presentation is part of an on-going effort by Attorney General Chris Koster to provide government officials with the support they need to be well informed in conducting their business in a way that brings transparency and fairness to all aspects of government. Topics covered in the presentation will include: Who does the Sunshine Law apply to? What is a public meeting? What is a public record? Liberal construction of the law; Procedures and limitations for closing meetings and records; Appointing a custodian of records; and Fees for copying public records. The Attorney General's Office also offers a free booklet containing a summary of the Sunshine Law, frequently asked questions, interpretations of the law and sample forms for public governmental bodies. # Integrating Photo Images in the Field to Enhance Your GIS

This presentation will highlight the process of moving GIS data into the field and then linking a digital image to the feature. This can be accomplished with or without GPS measurements. This results in a very powerful combination of location and image that can be integrated back into your GIS. In the past, it was necessary to manually link these two which is a tedious and error-prone process. Now, with wireless technology, it is possible to send the image directly to your data collector or GPS receiver while out in the field. The link is made automatically in the field. This can be accomplished with a variety of configurations and cameras. The discussion will also highlight some integrated camera options and reasons this option may be appropriate. Equipment will be available for demonstration of the technology.
