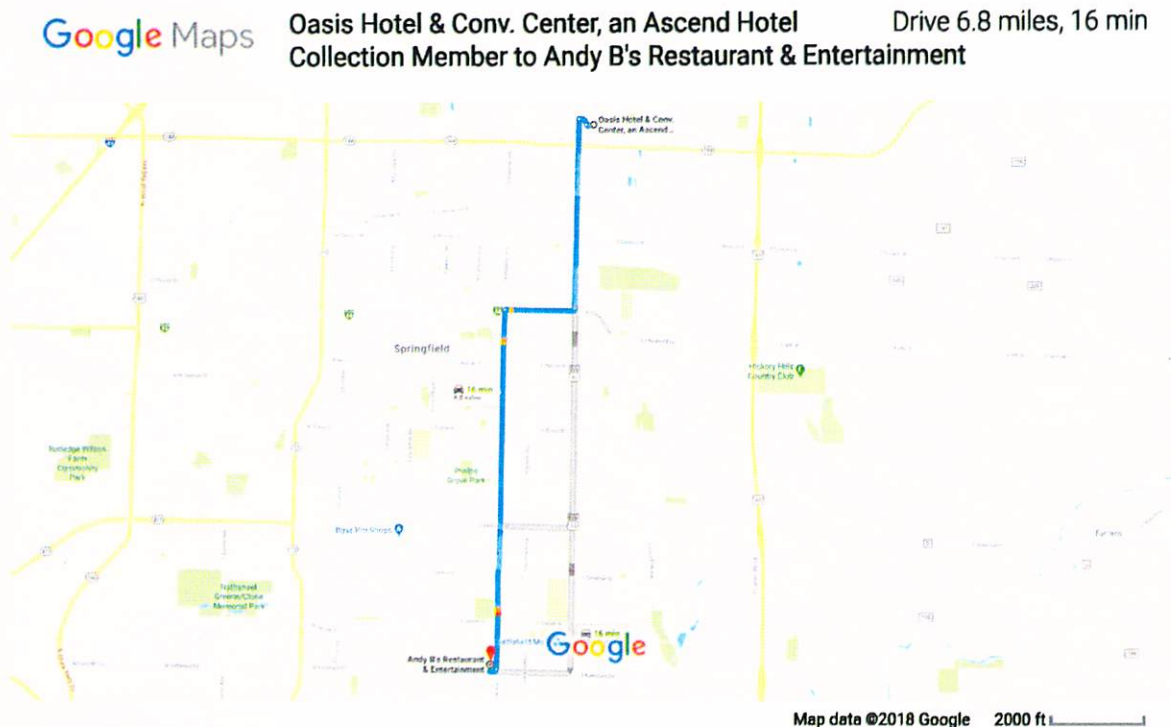


## CONVENTION CENTER MAP

#### ***Introduction to ArcGIS Pro Workshop - Ken Wilkerson, GISEDGE, Inc.***

*This workshop will help you get ready for your conversion from ArcMap to ArcGIS Pro. Using terminology that you are familiar with, the instructor will introduce you to the new Pro interface. You will get an understanding of the new ribbon/tool interface, get familiar with the new ArcCatalog pane in Pro, and learn how to do the basic things we do every day in ArcMap (working with symbology, layer properties, queries, etc.). The course is not an introduction to GIS concepts. It is a migration course, for those who are already comfortable with ArcGIS Desktop (ArcMap).*

#### ***Getting Started with ModelBuilder - Ken Wilkerson, GISEDGE Inc.***

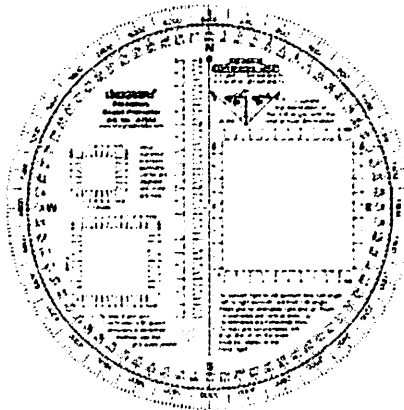
*Esri ModelBuilder (MB) provides a visual programming environment for combining data and tools to automate tasks and create custom tools. This course will introduce MB processing with hands-on exercises demonstrating the creation of models ranging from simple to complex. You will learn how to quickly and effectively develop models that help you become more productive ArcGIS users.*

#### ***From Deed to Parcel Map - Beginner - Christopher Dunn, GeoVelo, LLC***

*This workshop will take you through a brief history of cadastral mapping from pen & ink to GIS. You will gain a better understanding of "Deed to Parcel Map". When did parcel mapping start? Why are the property lines drawn there? How accurate do parcel maps have to be? No matter what mapping program you're using, it's important to know how to make the transfer from "Description to Map".*

#### ***From Deed to Parcel Map - Advanced - Christopher Dunn, GeoVelo, LLC***

*This is a continuation of the beginner workshop. We will go in-depth on how to deal with difficult property descriptions, property boundary conflicts, and chain of title. What is there's an overlap? What if the description doesn't close? What are the rules or standards of Cadastral Mapping? Are there any Missouri Statutes to follow? This will be a Q & A workshop as well, so have your questions ready.*

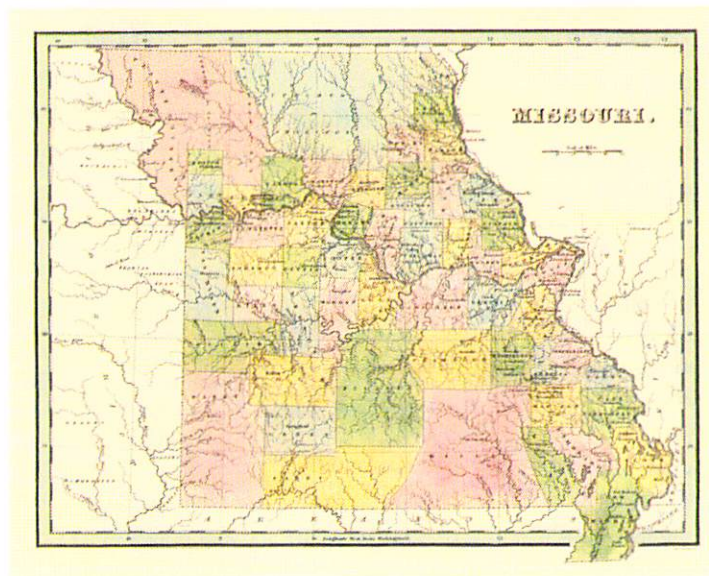
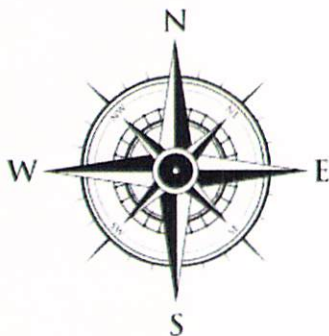
### Keynote Speaker, Thursday August 8<sup>th</sup>

#### ***"Shaping Missouri" - Dr. Richard Elgin, Archer-Elgin Engineering & Surveying, Inc.***

*How did Missouri get its odd shape? Were its boundaries surveyed? When? What's the boundary description for the State? Are the boundaries fixed, or do they move? Were the State boundaries ever contested? For the State's riparian boundaries....where are they located? Answers to these questions (and more) during this interesting session.*



*Dick Elgin was raised in his parents' surveying business in Rolla, Missouri. He received his BSCE and MSCE from Missouri S&T, and his PhD from the University of Arkansas. He flew helicopters in Vietnam, and remains active in veterans' affairs. For many years, he owned Elgin Surveying in Rolla, now Archer-Elgin Engineering & Surveying. He is an Adjunct Professor of Civil Engineering at MO S&T. The author of several books, he wrote "The U.S. Public Land Survey System for Missouri" and "Shoulda Played the Flute", a memoir of his flying helicopters in Vietnam. His current project is a book about riparian boundaries.*

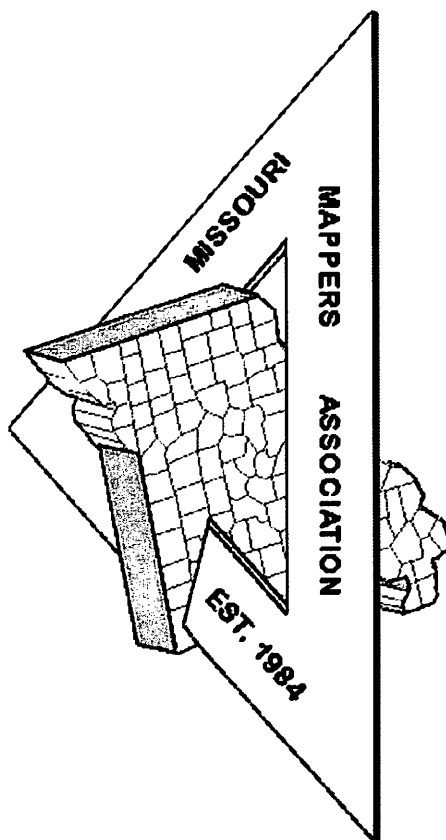

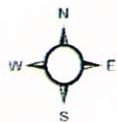
